Our sheltered count was conducted in the same way that it has been in previous years. Data was collected from both agencies that participate in HMIS and non-participating agencies.

Our count of sheltered persons in Emergency Shelter was 59 more than in 2021. Even with COVID-19 shelter decompression, our non-congregate shelter and overflow capacity increased. Some of this was due to additional funding related to COVID-19 for vouchers and the use of non-congregate hotel to mitigate the spread of COVID-19 and protect vulnerable populations.

We had an increase of 64 persons served in beds categorized as Transitional Housing. This is in part due to shifting inventory usage returning to pre-pandemic capacity levels and an additional GPD project of 10 beds being brought online.

Please provide a brief description of these specific factors (500 word limit):

Our 2021 Count implemented strong COVID-19 precautions and was conducted as an observation only count with fewer volunteers, limited geographic coverage. 2021 was also the first year we used sampling and extrapolation which we believe led to an inflated count.

Our 2022 count of 281 is only 13 more than our pre-pandemic 2020 count and is a better reflection of our current unsheltered numbers.

Continuing our efforts from previous years, our community utilized a comprehensive Point in Time Task Group to plan and implement the PIT 2022 count. Members of the task group included representatives from the Salt Lake County Collaborative Applicant team, HMIS lead, CoC board members, local city and county government, service providers, advocates, and law enforcement. The result was an inclusive and strategic planning effort. This included a robust training plan including a general PIT training and a technical training for the app use, but also covered information about youth homelessness, trauma informed approaches, valuing cultural diversity, and insights about unsheltered homelessness along the Jordan River Parkway.

Prior to the Count we utilized drones to focus efforts on specific remote areas that showed signs of camping. Volunteers from the Jordan River Commission paddled along the Jordan River and used location technology to drop pins on digital maps to indicate river encampments. This ensured that our surveying efforts were informed, efficient, and effective.

Our data collection effort utilized a mobile app, with optional paper surveys. The Esri ArcGIS Survey123 platform was programed by the GIS specialists in the Salt Lake County Surveyor\\'s office in partnership with the HMIS lead and the PIT task group members. Census tracts were used as a layer on the app to help assign volunteers specific geographic areas.

We experienced a great turnout of more than 200 volunteers to help throughout the three days of the Point in Time Count, and the increase in volunteers and the comprehensive planning strategy allowed us to better cover territory throughout Salt Lake County.
