- 1) Coordination. Salary, benefits, and space costs (S,B & SC) for .5 planning staff and 1.00 communication staff. Working in partnership with State, County, and City ESG funders, as well as other external stakeholders such as nonprofits, businesses, and private funders. Participate in the Utah Homeless Network to align standards and efforts for homeless service delivery statewide, and promote community funding priorities to Private and Government Funders. Communicate activities & initiatives to stakeholders in an inclusive & accessible manner. Participate in educational & community resource events to help educate & support. Creating & publishing all public communications & Coalition website information. Handle all media requests, creating & writing content advised by the Coalition, & staying informed on all community events surrounding work of the CoC.
- 2) Evaluation. (S,B & SC) for 1.00 for training & technical assistant staff FTE. Will be responsible for evaluating CoC programs. Staff will consult with recipients, sub recipients, & the data work groups of the SLVCEH to establish performance targets appropriate for population & program type. Staff will use benchmarks to evaluate outcomes & the system & program levels. Analysis of system gaps & disparities will also be conducted. Assist Coalition with all training needs throughout the year including the development & distribution of trainings. Provide technical assistance on projects supported by the CoC & related topics.
- 3) Monitoring. (S,B & SC) for .3 FTE planning staff. Program, performance, & fiscal monitoring of CoC funded projects will be conducted. Key benchmarks include: monitor grantee compliance with written standards for providing Continuum of Care assistance, monitor grantee compliance with HUD drawdown requirements & expense eligibility. Provide training & technical assistance to grantees.
- 4) Consolidated Plan. (S,B & SC) for .0125 FTE to Support the development of the Consolidated Plan to aligns with ESG & other partners, & help communicate efforts to stakeholders.
- 5) Grant Application. (S,B & SC) for .375 FTE planning staff. Activities will include coordination of the CoC Consolidated Application: dissemination of HUD requirements/guidance, ranking committee staffing & material development, project applicant training material development & conducting training meetings, collaborative application project management, as well as post-competition debriefing meetings.
- 6) System Development. (Š,B & SČ) for 1 FTE planning staff. Responsible for analysis, long-term strategic planning, & updating policies & procedures. Will also assist with the following core responsibilities: 1) Help coordinate CoC membership & board meetings 2) Coordinate annual invitation for new members 3) Provide support to subcommittees/task groups, & 4) Provide technical assistance & training to CoC members & grantees. As part of System Development activities \$10,000 will be used to provide stipends for the time homeless & formerly homeless individuals participate in CoC activities & meetings, and \$14,924 for technology solutions related to systems improvement.
- 7) HUD Compliance Activities. (S,B & SC) for .26 FTE planning staff to complete HUD reporting related to the PIT, HIC, and LSA and coordination and execution of the annual Point In Time Count. Aligning & supporting Coordinated Entry activities.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Estimated Schedule:

- 1) System Development Activities include: a) CoC Collaborative Applicant representation at Salt Lake Valley Coalition to End Homelessness and HMIS Steering Committee meetings and b) Administrative support provided at Task Group and Coalition meetings as well as maintenance and updates of a CoC website, social media, and newsletter.
- 2) Each CoC funded program will have at least one on-site monitoring visit per year.
- 3) Each CoC funded program will undergo a review of system performance measures quarterly. A review of the SPMs will take place in coordination with the HMIS team and the data work groups.
- 4) CoC Grantee technical assistance and training on CoC related topics will be conducted quarterly.
- 5) CoC Application Coordination will be a year-round process that includes precompetition preparation, NOFO response, post-competition debriefing, and post-competition action plan for community follow up.
- 6) Coordination activities will take place on a bi-monthly basis and include: a) CoC Collaborative Applicant representation at State, County, and City ESG funders' coordination meeting b) Participation in bi-monthly SLVCEH membership meetings c) Participation in bi-monthly Core Function Group meetings (held in opposite months of membership meeting) as well as task group meetings.

Management Plan: Staff funded by HUD CoC Planning dollars will receive direct supervision from a Salt Lake County staff member as well as additional management support from the Deputy Mayor. The staff fulfilling the duties of the CA will work closely with the SLVCEH (which serves as the CoC Board) and other CoC stakeholders to maintain transparency, accountability, and ensure roles and responsibilities are being fulfilled.

Method for Assuring Effective and Timely completion of all work: CoC Planning Grant staff will provide regular updates to the SLVCEH. CoC Planning Grant staff, in collaboration with the Board, will develop a scope of work and planning calendar for tracking progress and deadlines.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

Salt Lake County government currently administers and monitors ESG projects in the same geographic area served by the Salt Lake County Continuum of Care. This structure benefits the Continuum by encouraging coordination between ESG and CoC projects and ensures more efficient use of funds. The CoC has access to the expertise, resources, and innovation of the Salt Lake County government regarding evaluation of data and projects. Building upon existing procedures, monitoring activities will be used to inform strategy, help grantees understand their current data and performance measures, and improve outcomes. Technical assistance will be available to help new programs and to strengthen existing programs. Similar coordination occurs with Salt Lake City and the State of Utah for CoC and ESG grantees within the Continuum. Policies and procedures governing these programs have been developed collaboratively, and where possible monitoring schedules are coordinated. Participation in the Utah Homeless Network provides further opportunities for coordination. Planning staff participate in project evaluation and State funding decisions which includes ESG funded projects.
